- If I want to designate a person to act on my behalf and have access to my confidential information or documents in dealings with Revenu Québec after my income tax return has been accepted, I must file form MR-69-V, Authorization to Communicate Information or Power of Attorney, to give an authorization or a power of attorney to that person.
- Revenu Québec will be responsible for ensuring the privacy of the tax data filed online only once it has access to that data.

I certify that the information provided in this form and in the income tax return (which the preparer identified in Part 2 is authorized to file online) is accurate and complete, and that it fully discloses all my income.
