


With regard to my **communication preferences**, I understand that:

With regard to my **income tax return**, I understand that:

- I must keep all information slips, RL slips, schedules, registers, books of account and other documents needed to prepare my income tax return for the taxation year concerned and provide these documents and information at Revenu Québec's request.
- The information contained in the income tax return concerned, which was filed at my request by the preparer identified in Part 2 (and confirmed received by Revenu Québec), is deemed to have been filed by me.
- The preparer identified in Part 2 can obtain information only if the information is directly associated with preparing and filing my income tax return and only up to the moment Revenu Québec accepts the return.
- If I want to designate a person to act on my behalf and have access to my confidential information or documents in dealings with Revenu Québec after my income tax return has been accepted, I must file form MR-69-V, *Authorization to Communicate Information or Power of Attorney*, to give an authorization or a power of attorney to that person.
- Revenu Québec will be responsible for ensuring the privacy of the tax data filed online only once it has access to that data.

I certify that the information provided in this form and in the income tax return (which the preparer identified in Part 2 is authorized to file online) is accurate and complete, and that it fully discloses all my income.
